

Notice of Vote on Order of Road Discontinue

The Municipal Officers of the Town of Warren having filed with the Town Clerk the Order of Discontinuance for the purposes of discontinuing a portion of the public way known as the Packard Mill Road as hereinafter described pursuant to the provisions of Section 3026-A of Title 23 of the Maine Revised Statutes, and the Municipal Officers having given notice of the said discontinuance to Robert John and Ruth Dreher and Robert Craig Dreher, being all of the abutters to said portion of said way, and to the Municipal Planning Board, it is hereby:

ORDERED, that, pursuant to the provisions of Section 3026-A of Title 23 of the Maine Revised Statutes, Town of Warren, Maine does hereby discontinue and terminate all its interests in that portion of the way known as Packard Mill Road which is bounded and described as follows:

Traveling from the intersection of Rte.90 onto the Packard Mill Road for 1868 feet to pole #7~~B~~^A. This portion will remain a public way. The discontinued road starts at pole #7~~B~~ and runs in a southeast direction for 1037 feet till it dead ends. The width of this road is 49.5 or 3 rod. Shown more particular on the Town Tax map Numbers R11 - 044 & R11 - 44-1, on file at The Warren Town Office 167 Western Road.

FURTHER ORDERED, that no damages are awarded to any person by reason of this discontinuance of said portion of said way.

FUTHER ORDERED, that the grantors grant a Turn Around Easement unto the Town Of Warren, a municipal corporation situated in Knox County.


